The Illinois Environmental Protection Act Section 3.457 describes: "Special Waste" and waste which may be certified under Section 22.48 by the generator to be Non-Special Waste. By completing this Certification, the Non-Hazardous Waste listed above, meets all the requirements of the legislature amendments and is classified as a Non-Special waste. This waste can be managed as a municipal solid waste in the State of Illinois since this waste:

- Is not regulated Hazardous Waste (40 CFR 261 & Illinois Title 35, Part 722.11)
- Is not a Potentially Infectious Medical Waste (Illinois EPA Section 3.360)
- Is not a Liquid Waste (passes the Liquid Paint Filter Test, Illinois Title 35, Part 811.107)
- Is not Regulated Asbestos Containing Material (RACM), (NESAAPS 40 CFR Part 61.141)
- Does not contain regulated Polychlorinated Biphenyl's (PCB's) (40 CFR part 761)
- Is not formally Hazardous Waste rendered non-hazardous (De-Listed waste or De-Characterized)
- Is not a waste generated by shredding or processing recyclable metals (Auto Fluff) (IL EPA Section 22.29)

The information used in the determination of this waste to be a Non-Special Waste is by one or more of the following:

- Analytical Report from a laboratory responsible for testing results, signed & dated (when required)
- The relevant Material Safety Data Sheet (MSDS) (if applicable) and/or
- A signed and dated letter of generator knowledge

By signing this certification, the generator understands that anyone who knowingly and falsely certifies that an industrial process or pollution control waste is not a special waste commits a Class 4 felony for the first offense and a Class 3 felony for the subsequent offense and is subject to the penalties in Section 44 of the Illinois Environmental Protection Act. If the waste certified as a Non-Special Waste would qualify as a Pollution Control Waste under 415 ILCS 5/3.335 and Perry Ridge does not separately charge the generator for Solid Waste Management Fees or Subtitle D Management Fees under 415 ILCS 5/22.15 (l) or 415 ILCS 5/22.44 (b), respectively, on the basis that such waste is exempt from such fees due to its character as a Pollution Control Waste, but the Illinois EPA or any governmental authority subsequently demands payment of fees under 415 ILCS 5/22.15 (k) or 415 5/22.44 (b) with respect to such waste, the generator shall reimburse Perry Ridge for the amount of such fees. This Non-Special Waste Certification is effective from the date signed and must be retained for three (3) years following termination of the process that produced the waste. A new certification must be submitted if there is a change in the Generator name and/or address, in the raw material used, or in the process of generating the waste.
